The subject matter of the agreement is the doctoral thesis or habilitation thesis as designated in Annex I, including the abstract and any additional material (materials).

1. Granting rights

In accordance with the "General Guidelines for the Submission of Habilitation Theses to the University Library" or the "General Guidelines for the Submission of Doctoral Theses" as adopted by the Senate of the LUH, I hereby grant to the TIB, the LUH, the German National Library in Frankfurt/Leipzig and, if applicable, to the institution operating the respective specialist information service the non-exclusive right to use such materials (including any academic career that may be included) in whole or in part and, regardless of the transmission technology or the like, to make such materials available for download to the public in data networks worldwide, to archive them permanently, to reproduce, distribute, edit and use such adaptations for the aforementioned purposes in all formats and on all digital or analogue data media.

2. Third party rights

I hereby assure that third-party (e.g. co-authors, probands, publishers, collecting societies, third-party donors) rights (e.g. copyrights, data protection) shall not be infringed or violated by the provision of such materials including all their components (e.g. illustrations) and additional material, if any. I shall indemnify and hold harmless the LUH and the TIB from all and any claims third parties may raise against them on the basis of rights they are entitled to, provided that I am responsible for this (incl. costs of prosecution). The LUH and the TIB shall be entitled to block access to a document provided that there are concrete indications for an infringement of third-party rights. The contracting parties undertake to inform each other immediately if third parties assert claims against them on the basis of the rights, they are entitled to having regard to the materials described in Annex I.

3. Long-term preservation

I hereby grant to the LUH and TIB the right and confer on them the duty to store the submitted documents and the corresponding metadata, abstract and additional material, if any, in their long-term archive and, if so required (e.g. by migration, barrier-free access or better accessibility) to convert them into other electronic and physical formats.

5. Transferring conferred rights to third parties
